get to where you are today?" Overall, the teleconference went smoothly, ending with a positive vibe throughout the room and enlightened outlook on the political process for all of those present.


## Boys' State to hear Governor JIM

Jim Gibbons was born and raised in Sparks and attended Nevada public schools and universities. He earned a B.S. in Geology from the University of Nevada, Reno, and a Master's degree in Mining/Geology from the University of Nevada's Mackay School of Mines. Gibbons went on to earn his J.D. from Southwestern University School of Law and completed his post-graduate work at the

University of Southern California. Gibbons is a former combat pilot and decorated veteran of both the Vietnam and Persian Gulf Wars. To start his political career, Gibbons served three terms in the Nevada State Legislature rising through the ranks to become Republican Whip of the State Assembly. Jim Gibbons was first elected to represent Nevada's 2nd District in the House of Representatives in 1996 and after being elected to a fifth term in November 2004, and decided to leave Congress to run for
